The Human Colossus Foundation (HCF) is a Swiss-based independent non-profit organisation. HCF works globally to create and implement the critical infrastructure for a data-agile economy, the Dynamic Data Economy (DDE). DDE enables a new paradigm in digital living, interaction, and growth, underpinned by groundbreaking concepts and technologies. HCF coined the term DDE with a vision of it empowering people and businesses to make better-informed decisions based on insights from harmonised, accurate data framed by sound data governance. Founded in 2020, HCF has successfully secured multiple rounds of government and private funding to build the initial core public utilities for the DDE, ready for release in 2022. In parallel to the rollout, HCF is opening up limited funding opportunities to strategic donors in the private sector through the Founding Donors' Programme to fuel the next phase of development and early adoption of the DDE.

Make a long-standing impact by investing in DDE

The DDE is essentially a decentralised trust infrastructure acutely aligned with the European data strategy where actors have the transactional sovereignty to share accurate information bilaterally. To achieve that, HCF facilitates the development of standards and tools that guarantee the structural and contextual integrity of all digital objects, the factual authenticity of any recorded event, and the consensual veracity of purpose-driven data agreements. This approach brings about new structures free from existing economic models while providing bridges to existing standards and legacy infrastructure.

According to expert projections, the estimated global cost of cybercrime will reach approximately USD 10.5 trillion by 2025. A fully-functioning DDE could drastically reduce cybercrime rates, thus significantly lowering financial and reputational costs incurred by businesses and individuals, such as

- damage and destruction of data
- identity theft, personal and financial data theft, reputational harm, deletion of livelihoods
- money deprivation, fund embezzlement, fraud
- intellectual property theft
- post-attack disruption to the standard course of a business, dramatic loss of productivity
- the loss or distortion of evidence in forensic investigation, falsification of evidence, manipulation of documents

By restoring users' trust in the next generation data infrastructure, a DDE will also boost scientific usage of data and the adoption of digital innovations.
